
### Discover...

## Bachelor programmes

**Economics and Finance** is a joint Bachelor's programme of the Faculty of Economics. University of Belgrade and University of London (academic direction by LSE) lasting 4 years - 240 ECTS. This programme offers outstanding career opportunities, in international organizations, financial institutions, public sector, non-for-profit organizations or academia. Modern design of the programme and provides good foundations for those who want to pursue postgraduate studies. At the end of the programme students are awarded two degrees - by the University of London (LSE) and by the University of Belgrade (Faculty of Economics).

Business and Management is a joint Bachelor's programme of the Faculty of Economics, University of Belgrade and University of London (academic direction by LSE) lasting 4 years - 240 ECTS. This programme offers outstanding career opportunities and prepares students for a career in the areas of business, banking, general management, accountancy, management consulting and marketing. At the end of the programme students are awarded two degrees - by the University of London (LSE) and by the University of Belgrade (Faculty of Economics) and they can apply for postgraduate programmes in Serbia and worldwide.

## **Master programmes**

**European Politics and Crisis Management** is a one vear Master's programme offered by the University of Belgrade. It provides students with education in the field of public administration and humanitarian activities and a qualification of Master of Crisis Management. The program has an interdisciplinary character with interactive teaching methods. In addition to the theoretical cognitive content, candidates will be able to explore specific social problems through workshops and have practical training in relevant institutions. The program provides students with professional and applicable knowledge to identify, prevent and resolve social crises. This master's program qualifies students to participate in projects and find professional employment in relevant institutions and organizations that require effective and operational management.

Advanced Data Analytics in Business is a one year Master's programme at the Faculty of Economics, University of Novi Sad. The purpose of the study program is education in the field of advanced data analytics (data science) through:

- mastering competencies in understanding big data, their preparation, modelling, evaluation and implementation of solutions in business
- the application of programming, statistics, machine learning, data manipulation, visualization, and respecting codes of ethics.

Besides the teachers from University of Novi Sad, the courses are delivered by professors from renowned universities from Italy, Austria, Germany, France and Greece. Experience...





International Business and Management is a joint Master's programme of the Faculty of Organizational Sciences. University of Belgrade and Middlesex University Business School, London, UK. The programme offers a sound understanding of international business and management and trains students to effectively perform managerial functions in a global environment. Since the programme is accredited in both countries, students gain two degrees - Serbian and UK one. The programme is delivered over three semesters for a period of 18 months

Public Procurement Management (MPPM) is a joint Master's programme of the Faculty of Law. University of Belgrade and the University of Rome Tor Vergata, Department of Economics and Finance. After successful completion of this one year study programme a student acquires a joint Master's degree of the University of Belgrade and of the University of Rome Tor Vergata with the academic title: Master in Public Procurement. The purpose of the MPPM is to provide an interdisciplinary training on many aspects of public procurement responding to the national and international need to train students and public procurement professionals and prepare them for modern challenges arising in the this profession.

one year Master's programme offered at the Faculty of Law. University of Belgrade. The educational process is conducted by prestigious academics from the University of Belgrade. Faculty of Law, in cooperation with the visiting professors from the EU Consortium of Faculties. The aims of this study program are to offer adequate knowledge and capabilities for working in both legal and non-legal jobs related to the integration into the European Union. The knowledge of the laws and politics of the European Union is used in state administration. the business, information, education and civil sector, as well as in research and scientific institutions. Additional courses and visiting lectures are organized each academic year, and the students receive certificates for attending them.

The Faculty of Economics, University of Belgrade offers international master's programmes fully taught in English. These programmes share some courses, which creates unique opportunities for students to network and establish connections with local and international partners of the Faculty.

International Master in Quantitative Finance (IMQF) is a one-year programme that provides a background for all three levels of the Chartered Financial Analyst (CFA) exams and globally recognised risk management exams such as FRM and PRM. The IMQF programme schedule permits students to work full-time jobs while pursuing a highly competitive master's degree. Some former IMQF students continued their education towards a PhD in

Master in Applied Economics (IMAE) a one-year programme that trains students to combine innovative theoretical models and practical tools to evaluate the economic phenomena and economics policy. In addition to high-quality academic training, which is delivered by renowned domestic and international academics and reputable guest lecturers, this programme provides options for internships at national and European policy and financial institutions, think tanks and corporations. This programme offers outstanding career opportunities in international organizations, financial institutions, the public sector, non-profit organizations and academia.

Master in Taxation (IMT) is a unique, multidisciplinary programme jointly organised by the Faculty of Law and the Faculty of Economics of the University of Belgrade. This program represents a unique opportunity for those who want to develop their professional careers in taxation, as well as in financial and legal advisory, since it provides students with a legal and economic perspective of the tax phenomena by combining a modern academic framework and set of skills in law, economics, finance and accounting. IMT is available to students who hold bachelor's degrees with 180 ECTS and 240 ECTS and can last for 1 or 2 years.

Master in Business Informatics (IMBI) is designed for students who aim to acquire a broad understanding of information systems and want to develop an interdisciplinary approach to management of IT projects. Since IMBI is fully taught in English and all the used tools are up-to-date products of the most renowned companies, the completion of the study enables a great career in business informatics in public and private sector, international organizations and academia. Programme lasts for 1 or 2 years.
